In all the rules that govern this regatta, the notation [NP] refers to an infraction of this rule. This modifies rule 60.1(a).

The notation indicated as [SP] will be fixed, without a hearing and imposed by the race committee, in the most recently completed race, applied as indicated in rule 44.3 RRV or a [DP] imposed by the Jury with a hearing. (Modifies rules 63.1 and A5 of the RRV).



VENUES AND DATES

The 10th Comunitat Valenciana Olympic Week (CVOW) will be held from January 30 to March 4, 2025, inclusive, organized by the Real Club Náutico Torrevieja, Club Náutico Santa Pola, Real Club de Regatas de Alicante, Real Club Náutico de Valencia, and the Federación de Vela Comunitat Valenciana by delegation of the Real Federación Española de Vela.

1. RULES

The regatta will be governed by:

- 1.1 The “rules” as defined in the current Racing Rules of Sailing (RRS), including Appendix B for Windsurfing, Appendix E for the IOM Class, and Appendix F for Formula Kite, and additionally;
- 1.2 Será de aplicación el Apéndice P del RRV, excepto para Kiteboarding y Windsurfing.
- 1.3 The Competition Regulations of the RFEV in the Spanish Cups and Championships.
- 1.4 The Competition Regulations of the FVCV in the regional cups and regattas that are not Spanish cups and championships.
- 1.5 [DP] The Rules of the Participating Classes.
- 1.6 [NP][DP] The equipment instructions that are part of the Sailing Instructions.
- 1.7 [NP][DP] The World Sailing Equipment Rules (ERS).
- 1.8 ILCA Class Rule No. 7(a) is modified as follows: “Only one person, who will be registered as the skipper, will be on board during the race.”
- 1.9 For the 29er, 49er, and 49erFX Classes, RRS 44.1 and P2.1 are modified so that the Two Turns are replaced by One Turn.
- 1.10 [NP][DP] Support persons may be required to use personal flotation devices while afloat, and all support boats must be equipped with a functioning VHF radio.
- 1.11 RRS 90.3(e) is applicable.
- 1.12 RRS 40.1 “Personal Flotation Devices” is mandatory at all times while afloat.
- 1.13 [NP][DP] All sailors and support personnel will follow any reasonable instruction given by a member of the organization.
- 1.14 For the Wingfoil Class, it will be required:
 - 1.14.1 A protective helmet with a minimum standard of EN1385, EN1077, or equivalent, with at least 300 cm² of high-visibility exterior color, must be worn at all times while afloat, except briefly while changing or attaching personal clothing or equipment.
 - 1.14.2 Body protection (impact vest), which may also serve as personal flotation according to Class Rule C.3.2(b), must be worn at all times while afloat, except briefly while changing or adjusting personal clothing or equipment.
- 1.15 If there is a conflict between languages, the Spanish text will prevail.

2. ADVERTISING [NP] [DP]

- 2.1 Participants may be required to display advertising provided by the organization. If this rule is violated, rule 20.9.2 of the World Sailing Regulations will apply.

3. COMUNICATIONS

- 3.1 The official notice board online is located at: www.cvolympticweek.com



- 3.2 Except in an emergency, from the first signal of attention until the end of the last test of the day, a boat will not make or receive voice, radio or data transmissions that are not available to all boats. This restriction also applies to mobile phones.

All sailors must be registered with their Sailor Account, and coaches with their Coach Account.

4. ELEGIBILITY

- 4.1 Participants must meet the WS Eligibility requirements reflected in World Sailing Regulation 19 and the RFEV Prescriptions to said Regulation 19.
- 4.2 All Spanish sailors, with legal residence in Spain or competing representing a Spanish club, must be in possession of the RFEV valid federative license as well as be up to date with the obligations of the Class.
- 4.3 The Spanish Championships are closed regattas. Foreign sailors may participate by invitation from the RFEV.
- 4.4 In all classes competing in the Spanish Cups and Championships, the gender and age categories established in the RFEV Competition Regulations will be set, provided the minimum participation requirements are met.
- 4.5 On March 1, 2022, World Sailing published the following recommendations in response to the situation in Ukraine: <https://www.sailing.org/2022/03/01/world-sailingstatement-6/>. After this, the Higher Sports Council of the Government of Spain and the Royal Spanish Sailing Federation published recommendations along the same lines. To help preserve the integrity and security of this event the Organizing Committee will not accept participants who have only Russian or Belarusian nationality. The Organizing Authority will monitor the situation and adapt these recommendations and measures according to future developments in the current situation.
- 4.6 Underage sailors will have to be associated with a sports technician with a support boat with a ratio of 10 sailors per technician and support boat.

5. ENTRIES AND REGISTRATION

In the Techno 293, iQFoil Youth, and 29er classes, registrations must be made by the regional federations. The registration will not be considered complete until the registration fees have been paid and the registration process has been completed.

5.2 A representative of each boat must register at the regatta office of the venue where it competes, the day before the start of the first race, from 10:00 a.m. to 6:00 p.m., providing documentation that is listed below:

- Valid RFEV Federative License (Spanish sailors, with legal residence in Spain or who compete representing a Spanish Club)
- Civil liability insurance of at least 1,500,000 (foreign sailors)
- ID card or passport.
- Class Card.
- Measurement Certificate (classes that require it)

5.3 Coach and Support people must register at the regatta office at the same time as the previous section, presenting the following documentation:

- Valid RFEV Federation Technician License (only Spanish technicians). Spanish coaches of the 29er, Techno, and iQFoil Youth classes must present the federative license of Sports Technician TD2 or TD3 with fixed or free rigging as applicable.
- Title to operate the boat
- Boat civil liability insurance.
- Certificate of navigability

5.4 Competitors under 18 years of age will present a completed and signed parental (or guardian) permission slip upon registration. The form can be downloaded on the event website. www.cvolympicweek.com

The organization may cancel the regatta for those classes that do not reach the minimum registration quota on **January 21, 2025 at 00:00h.**

Sailors will be notified of this decision via email and it will be published on the event website. Registration fees for canceled classes will be returned.

In double-handed classes, only the registered skipper may helm the boat while racing, except briefly during a maneuver.

6.2 Late registrations will incur a surcharge of €30 per boat.

6.3 Cancellation policy:

After the registration deadline, the organizing authority reserves the right to refund the paid registrations.

7. FORMAT

The competition format will be specified in the Sailing Instructions and will be as similar as possible to that used in international competitions of the class in question.

8. SCHEDULE

8.1 The official schedule of the event will be published in the TOA, no later than January 20, 2025.

8.2 Two races must be completed for the regatta to be valid.

8.3 On the last day of racing no warning signal will be given after 4:30 p.m.



9. EQUIPMENT INSTRUCTIONS [NP] [DP]

- 9.1 In IOM and Europe Classes, each boat will present a valid measurement certificate (If required by its class rules).
- 9.2 Boats will be subject to measurement checks at any time during the event. Inspection procedures will be detailed in the Sailing or Measurement Instructions.
- 9.3 Equipment limitations, as specified in the class rules, will apply.

10. SAILING INSTRUCTIONS

The Racing Instructions will be available from January 30 in the Virtual TOA on the event website www.cvolympticweek.com.

11. RECORRIDOS

The racing areas and courses will be detailed in the racing instructions.

12. COACHING AND SUPPORT BOATS [NP][DP]

- 12.1 Coaching and support boats must be registered in accordance with section 5.3 of this AR, must comply with current legislation and display a flag, letters or any other form that is clearly identifiable to the sailors they support. The Organization may refuse registrations and/or accept late registrations at its discretion.
- 12.2 All support vessels will be equipped with a VHF transmitter in working order.
- 12.3 The organization may apply a registration supplement to sailors who are not accompanied by coaches; they will be published in the virtual TOA on the website.

13. GROUNDING AREA [NP][DP]

Boats on land will remain in the areas officially assigned by the organization

14. PRIZES

- 14.1 Champion of Spain or Spanish Cup plaques will be awarded to the winner of the regatta in each duly constituted category.
- 14.2 The prizes will be announced in the Virtual TOA on the event website

15. INSURANCES [NP][DP]

Each sailor will present civil liability insurance with coverage of at least €1,500,000 or equivalent per incident.

16. RISK STATEMENT

16.1 Sailing is by its nature an unpredictable sport and therefore inherently carries an element of risk. Sailors and on their behalf support staff participating in this regatta do so at their own risk. Attention is drawn to RRV 3, Decision to Bargain. By taking part in this regatta each participant accepts and acknowledges that:

16.1.1 They are aware of the element of inherent risk that the sport entails and accept responsibility for exposing themselves, their crew and their boat to such risk while participating in the race.

16.1.2 They are responsible for the safety of themselves, their crew, their boat and other property whether at sea or on land.

16.1.3 You accept responsibility for any injury, damage or loss to the extent caused by your own actions or omissions

16.1.4 By participating in any race, they acknowledge that their boat is in good condition, complying with the class rules, is prepared to sail in the race and in condition to participate;

16.1.5 The provisions of the race committee, safety boats, judges and other officials, as well as volunteers of the organization do not exempt them from their own responsibilities.

16.1.6 The provision of safety boats is limited to each assistance, especially in extreme weather conditions, as can occur practically in the circumstances.

16.1.7 It is your responsibility to familiarize yourself with any risks specific to this venue or this regatta by drawing your attention to any rules and information published for the venue/regatta and to attend any venue/event safety meetings held during the regatta.

16.2 All participants, coaches, technicians and companions are reminded of the obligation to maintain ethical and environmental conduct to preserve the environment. Failure to comply with this rule will lead to action by the Regatta Committee or the Protest Committee.

16.3 Royal Decree 62/2008 establishes the conditions of maritime safety, navigation and human life at sea applicable to nautical-sports events.

17. IMAGE RIGHTS [NP][DP]

17.1 By participating in this event, competitors automatically grant the organizing authority and its sponsors the right in perpetuity to make, use and display, at any time at its discretion, any image and live, recorded or filmed television or other reproductions of the athlete during the competition period, without compensation.

17.2 Boats may be required to carry cameras, sound equipment or GPS by the organizing authority.

17.3 Competitors will attend those interviews for which they are required by the organizing authority.
